RACV Great Victorian Bike Ride 2011

Terms and Conditions

1. Information on how to enter and prizes form part of these terms and conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is open to residents of Australia/NZ who are Bicycle Victoria members. Employees of the Promoter, the Promoter's associated companies, the Promoter's agencies associated with this competition and their immediate families are ineligible to enter.
3. The offer commences at 9am Australian Eastern Standard Time ("AEST") on Monday 1 August 2011 and closes at 11.59pm AEDST (Australian Eastern Daylight Savings Time) on Sunday 7 August 2011 ("Offer Period").
4. To be eligible for the free jersey, you must be a Bicycle Victoria member at the time of purchasing your entry in full on Mighty Murray or Goldfields RACV Great Vic Three-Day Ride Option.
5. You must send Bicycle Victoria a message via <https://www.bv.com.au/sendmessage/> and notify them of your name, rider number and jersey size by 7th August 2011.
6. Entry is limited to one jersey per person.

The Promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process, including but not limited to submitting multiple entries, or for submitting an entry that is otherwise not in accordance with these terms and conditions.
8. The free jersey that will be an official 2011 RACV Great Vic riders jersey.
9. Those eligible for the jersey will be notified by telephone and email w/c 8/8/11.
10. Eligible entrants will be entitled to collect their jersey on the RACV Great Victorian Bike Ride 2011.
11. If the entrant is unable to collect their prize from the ride, they can request to have it delivered to their address in Australia at Bicycle Victoria's expense post the ride.
12. The jersey is strictly not transferable.
13. The jersey is not redeemable for cash or exchange.
14. The jersey cannot be used in conjunction with any other discounts or special offers.
15. No responsibility is accepted for delayed, lost or misdirected correspondence.
16. Jersey value is correct at time of printing but no responsibility is accepted for any variation in the value of any prize items.

17. The Promoter is not liable for any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for personal injury suffered or sustained during the course of accepting or using the prize, except for any liability which cannot be excluded by law.
